Additional remarks

1. XXImo will initiate the set-up of the sFTP and the configuration of the folders.
2. The Account-ID needs to be applied in file name. The Account-ID will be provided by XXImo prior to the start of the testing activities and/or first production processes. This is needed for the automated processing activities of XXImo.
3. The naming of each data element needs to be respected.
4. The order of the data elements may differ if the naming is respected.
5. A request for terminating an account will lead to applying the status 'Pending Closed' to an account. This status can no longer be adjusted by the customer. An automated process of XXImo will change the status to 'Closed' after a period of 30 days. In between these statuses transaction(s) can be processed on the financial account.
6. When a Cardholder account status has been modified to 'Pending Closed' of 'Closed' because of a termination request it is no longer possible to request modifications of the account nor the underlying tokens (i.e., cancelling the termination or changing data or settings).
7. Re-opening an account is not supported, the underlying tokens have been blocked a result if the termination request.
